

Terms & Conditions for Bord Gáis Energy Little Readers

Bord Gáis Energy is giving registered Book Club members the opportunity to apply for a free book for their child.

Books are suitable for children age 0-5 years.

1. **Eligibility:** This offer is open to all members of the Bord Gáis Energy Book Club (aged 18 or over) who reside in the Republic of Ireland or Northern Ireland (excluding employees of Bord Gáis Energy (the 'Promoter') and its subsidiary companies, their agencies and anyone professionally connected with this promotion) who complete a 'Little Readers' registration form correctly before 5pm on Friday 15 July 2016 (the 'Closing Date'). Bord Gáis Energy reserve the right to end the promotion early in the event that the available stocks of books have been claimed.
2. **Prize/Promotion:** The member can register to receive a free book (only one request per member will be accepted for this Offer with a maximum of two books per household). Books are non-transferable and there is no cash alternative for the prize. All books will be posted to successful registrants after the campaign has closed. Please allow a minimum of 4 – 6 weeks for delivery.
3. **Communication:** The Promoter may contact registrants via phone, e-mail and/or any other means of communication for the purpose of notifying applicants and to attain delivery details etc.
4. **Promoter's Discretion:** The Promoter retains the sole discretion to withhold books without liability if, in its view, an applicant is ineligible, the entry is invalid or an applicant does not meet the necessary requirements as set out in these terms and conditions.
